

Privacy declaration

This privacy statement is part of the Online Registry website and explains how your personal data is handled.

The protection of your privacy is of utmost importance to us. Therefore, compliance with the legal data protection regulations is a matter of course for us. Furthermore, in the interest of transparency, it is important to us that you know at all times when we store which data and how we use it.

The confidentiality of your personal data is guaranteed by the fact that

- Your personal data, which is collected and communicated via the forms of the Online Registry, will be used exclusively by the organizer for the organization and handling of the conference as well as for information about further events. Your data will not be passed on to third parties.
- you have of course the possibility to be deleted from the Online Registry at any time.
- our employees and contractual partners are bound by legal and contractual confidentiality obligations and have to observe legal and contractually agreed duties of confidentiality, and
- our security precautions comply with the current state of the art to the extent reasonably required state of the art.

Storage of access data (server logs and history memory)

Your visit to our websites is logged. With every access and every file retrieval, the following data is recorded the following data is stored in a log file:

- The IP address that you receive when dialing into the network,
- name of the retrieved file or page,
- date and time of the retrieval,
- the content of the call and the amount of data transferred,
- message whether the retrieval was successful,
- Type of your web browser / operating system,

The storage is used exclusively for internal system-related and statistical purposes. An evaluation takes place only in anonymous form for statistical purposes without personal reference.

In addition, the course of each session in the online registry, i.e. each action, is logged user-related. This history memory is used for data security and is evaluated exclusively for the correction of errors. It is automatically deleted no later than 3 months after the event.

Use of personal data

Your personal data, which are requested with the mandatory and optional fields of the online registry are required for the following processes:

- Purchase of admission tickets
- Processing of participation
- Submission of entries
- Review of contributions
- Publication of contributions in the abstract volume, program booklet and, if applicable, scientific journals and databases
- Correspondence with you

Storage and archiving of personal data in the Online Registry

Three months after the conference, the Online Registry will be deleted and the data it contains will be archived for 10 years. If necessary, the Online Registry will make your data available exclusively to the professional society heading the conference.

Your rights

You have the right to request information free of charge about the personal data stored about you. In addition, in accordance with the legal provisions, you have the right to Correction, blocking and deletion of your personal data.

Surrender of personal data to law enforcement agencies and courts of law

Upon presentation of a judicial order and in the event that there is initial suspicion of a criminal act personal data will be disclosed to law enforcement authorities without informing you. We also reserve the right to use your data for legal proceedings in order to assert any civil claims (such as for payment of participant fees).

Cookies

Cookies are small text files that your browser automatically creates when requested by a visited website automatically. We use cookies in the registry area, in which information about usage is stored. After the session, the cookie is deleted. It cannot be created manually or used by another website. Cookies may also be used on linked sites without that we will point out to you beforehand. Most browsers are set to accept cookies automatically. However, you can deactivate the storage of cookies or set your browser to notify you when cookies are set. If you choose to decline cookies, you will not be able to use the the full functionality of Online Registry.

JavaScript

We use JavaScript to display our website. If you do not want to use these active content for security reasons, you should deactivate the corresponding setting in your browser. The use of the registry is not possible without JavaScript.
